I understand in full that what I am engaging in is extremely dangerous and I am risking injury or possible death. If injury does occur, I will not allow my personal health insurance company to recover any loss from said parties' insurance or personal finances. I will repay the insurance company myself if my personal insurance company attempts to recover loss from said parties. I will not pursue legal action against Chilhowee Sportsman's Club, LLC, land owners or company to recover loss of finances due to injury or loss of work. I also waive all rights for family members, legal representatives, spouses, estate, heirs, assigns or beneficiaries to seek legal action in the event of my death or severe injury where I can no longer speak for myself. I agree to accept full responsibility for any damage to shooting ranges, equipment, or damage to landowners' property caused by my actions. I am responsible for my personal property, (i.e., guns, etc.) while on this property. I agree to hold the landowners and company blameless for any mishap which may occur as a result of holes, rocks, hills, trees, or other irregularities in the land or walking trails, bee stings, snake bites, insect bites, defective guns or ammunition, human error or acts of God. I agree to hold said parties blameless while using company owned or personal golf carts, ATV's or any other manner of transportation in the event of accident while on property.

## Safety Rules

Absolutely **NO ALCOHOL** allowed on the course or prior to shooting.

**Eye protection and hearing protection** must be worn on shooting range(s) at all times.

**Do not load gun** until you are in the shooting station with the gun over the firing rail and pointed down range. Once loaded, keep your gun **over the gun rail** and pointed **down range** until all shells are removed.

Maximum of **two rounds** are to be loaded in your shotgun when preparing to shoot sporting clays. Shells no larger than **2¾ inch**, with shot size of **7½, 8, or 9 lead shot only!** To use anything else is a safety hazard.

Absolutely **no backup shooting**. Only the shooter in the station is allowed to fire at targets.

If you should break two targets with one shot, make sure **you eject the second round** before leaving the station.

**If your gun should jam or misfire, STAY in the shooting stand** with the gun pointed down range, over the gun rail. **Remove** the shells, check for and **clear any wad** from the barrel with orange stick (one at every station), and contact the range manager for assistance, if necessary.

At all times on this property: all pumps and automatics must have the **gun breach open** and all double barrels **broke open** so everyone can see the gun is not loaded. Only exception: double barrel shotguns may be closed if in the gun rack on a cart.

Anyone **under 16 years of age must be accompanied by an adult**.

You must have a **valid driver's license** and be at least 16 years of age to operate a Club Cart or any other vehicle on the property. When using our carts, they are for transport only, **NOT** for your pleasure (i.e., racing, etc.) If you damage a cart, you will be financially responsible for the repairs.

**Anyone not following these safety rules will be ejected from club property.**

Please be **courteous** and **respectful** to fellow shooters and staff.
