- 1. The risk of handling firearms and being near others that have firearms in their Possession;
- 2. The risk of ear damage from noise and the risk of eye(s) injury. For eye and ear protection, we recommend use OF ear plugs and protective eye glasses. If you do not, you are doing so at your own RISK.
- 3. the risk of injury from ammunition, clay targets and shot from other guns;
- 4. Inclement weather conditions. I understand the risks, hazards, and dangers as described above.

I understand these activities may require a degree of skill and knowledge. I believe I have the needed skill and

knowledge necessary to engage in these activities safely. I understand that I have responsibilities. My

participation in this activity is purely voluntary. I elect to participate in spite of the risks. I AM VOLUNTARILY

connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or
